FABRIC CARE

General external and environmental issues are inevitable to affect outdoor fabrics. Prompt attention to these areas will minimise the chance of permanent damage to fabrics.

To obtain the maximum life from Somerton® View fabrics, we recommend you follow these helpful maintenance items:

1. Keep the fabric clean by brushing regularly both on the top and underside with a soft bristled brush and by hosing occasionally with clean, cold water.
2. No high pressure washer to be used for cleaning fabric. This will result in the Warranty being voided.
3. Do not apply soaps, detergents, cleaning fluids or insecticides.
4. Keep petrol, oil, solvents, kerosene and other similar fluids away from the fabric.
5. Do not allow bird droppings, earth, sand, or vegetable matter to remain in contact with the fabric.
6. It is important that the awning or blind containing Somerton® View is kept down to dry after wet weather and should not be rolled up or stowed away when wet. Outdoor furniture and cushions should also be dried before storing away.
7. For stubborn stains clean thoroughly with a diluted non chlorinated bleach - 1:20 concentration mixture or DEFAB recommended solution. Rinse immediately with clean water and dry thoroughly before rolling or stowing away.

LIMITED 10 YEAR WARRANTY

Defab Group (DEFAB) warrant for a period of ten (10) years that Somerton® View sunscreen mesh;

- Will be free from major manufacturing defects. This does not include minor cosmetic weaving faults which may be present.
- Is manufactured to its published specifications.
- Will not degrade unreasonably as a result of UV and/or light exposure. Gradual fading or colour change is not covered by this warranty.
- Is fit for its intended purpose. Cosmetic degradation is not considered unfit for its purpose and will not affect the performance of the fabric.

In the event of a claim;

- This warranty is not transferrable and applies only to the original purchaser.
- DEFAB must be notified in writing within 14 days of the defect being identified.
- Proof of purchase and complete details of the fabric including batch details must accompany a valid claim.
- Warranty starts from the original purchase date of the fabric and the normal conditions of Sale of the Defab group applies in absence of any terms herein noted.

A claim is not valid if;

- The defect has been caused by improper use or the fabric is not used for the purpose that it was designed.
- The fabric has been subject to misuse, abuse and/or neglect.
- The fabric was not maintained in accordance with the FABRIC CARE recommendations published by DEFAB.
- The fabric has been altered or modified in any way.
- If the fabric has not been fabricated by a qualified tradesperson or to a reasonable standard of workmanship.

If Defab considers the claim to be valid;

- DEFAB will supply a suitable replacement fabric.
- DEFAB will not be liable for any consequential damage or loss as a result of any claim.
- This warranty applies to the fabric only. Other costs will be only considered at the discretion of DEFAB.

SCALED REPLACEMENT

The Somerton® View Warranty is based on the scale as outlined below. In the event of a validated claim, in the first five (5) years 100% of the fabric will be replaced. From six (6) to ten (10) years, the fabric is subject to sliding scale replacement value based on the service the fabric has already provided.
